Kajalgaon, Chirang, Pin-783385, BTR, Assam, through post or to be delivered by hand in the Application Drop Box at the office of the District & Sessions Judge, Chirang, Kajalgaon during office hours.
2. The last date of submission of application form is **30.05.2023 till 5:00 P.M.**
3. 'Envelope containing the application must be super scribed with the post applied for on the top of the envelope. For e.g. "APPLICATION FOR THE POST OF CONTRACTUAL STAFF FOR e-SEWA KENDRAS" in block capital letters.
4. The recruitment will be purely on contractual basis for a period of one year with no provision of regularization.

5. If any candidate is found to have suppressed his educational qualifications or to have given wrong information, at the time of applying for job or later on, his candidature shall stand rejected without any information to him with immediate effect and shall also be liable to Criminal Prosecution as per law.
6. Candidates must not be less than 18 years or more than 40 years of age on the last date of submission of application. The relaxation of age shall be applicable as per existing rules of the State Government.
